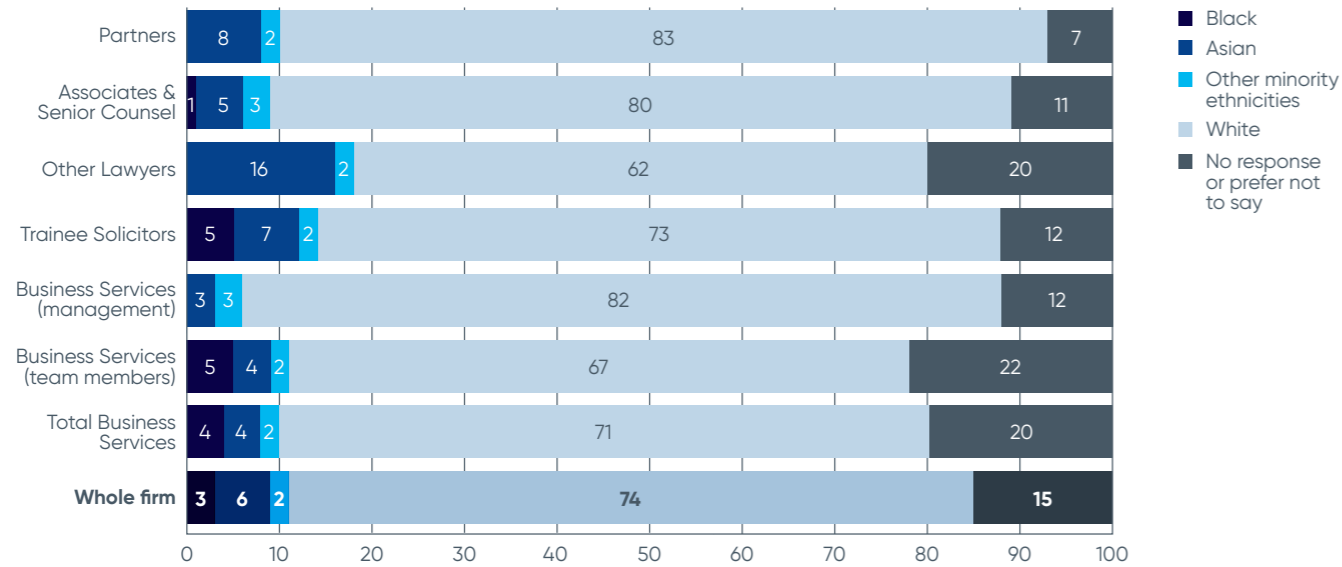

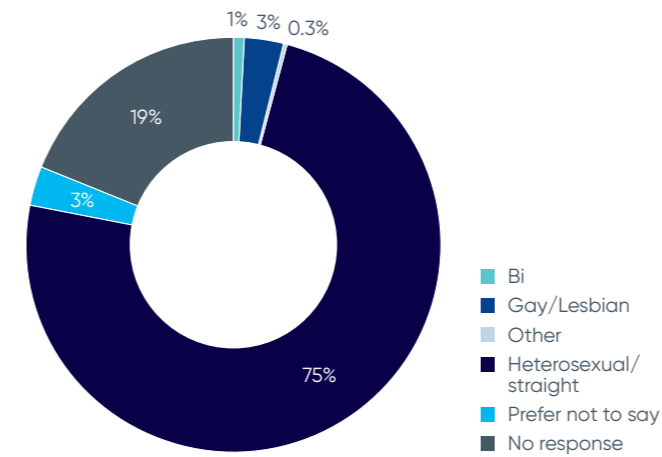

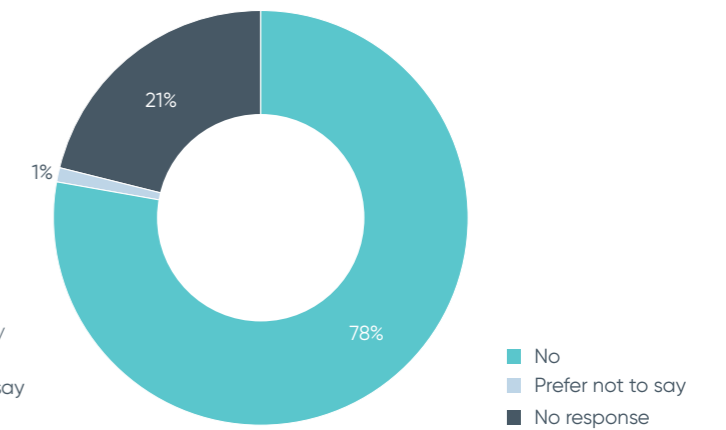

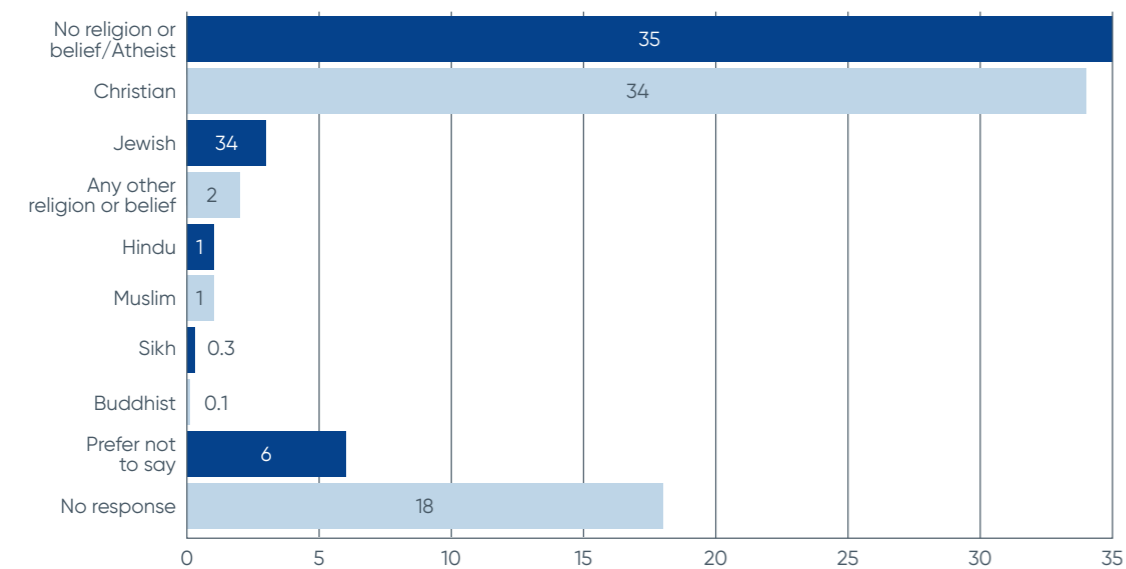

Do you identify as Trans?

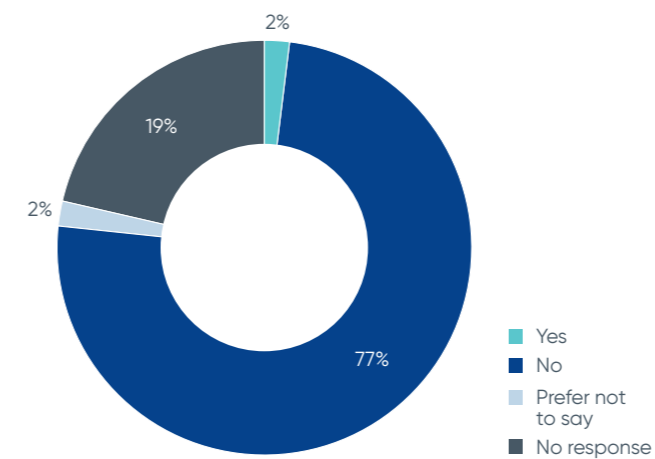

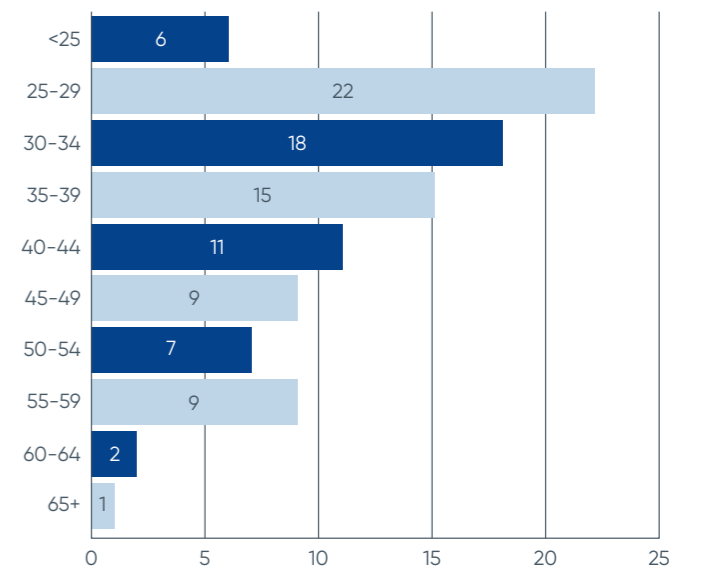

Do you consider yourself to have a disability according to the definition in the Equality Act 2010?

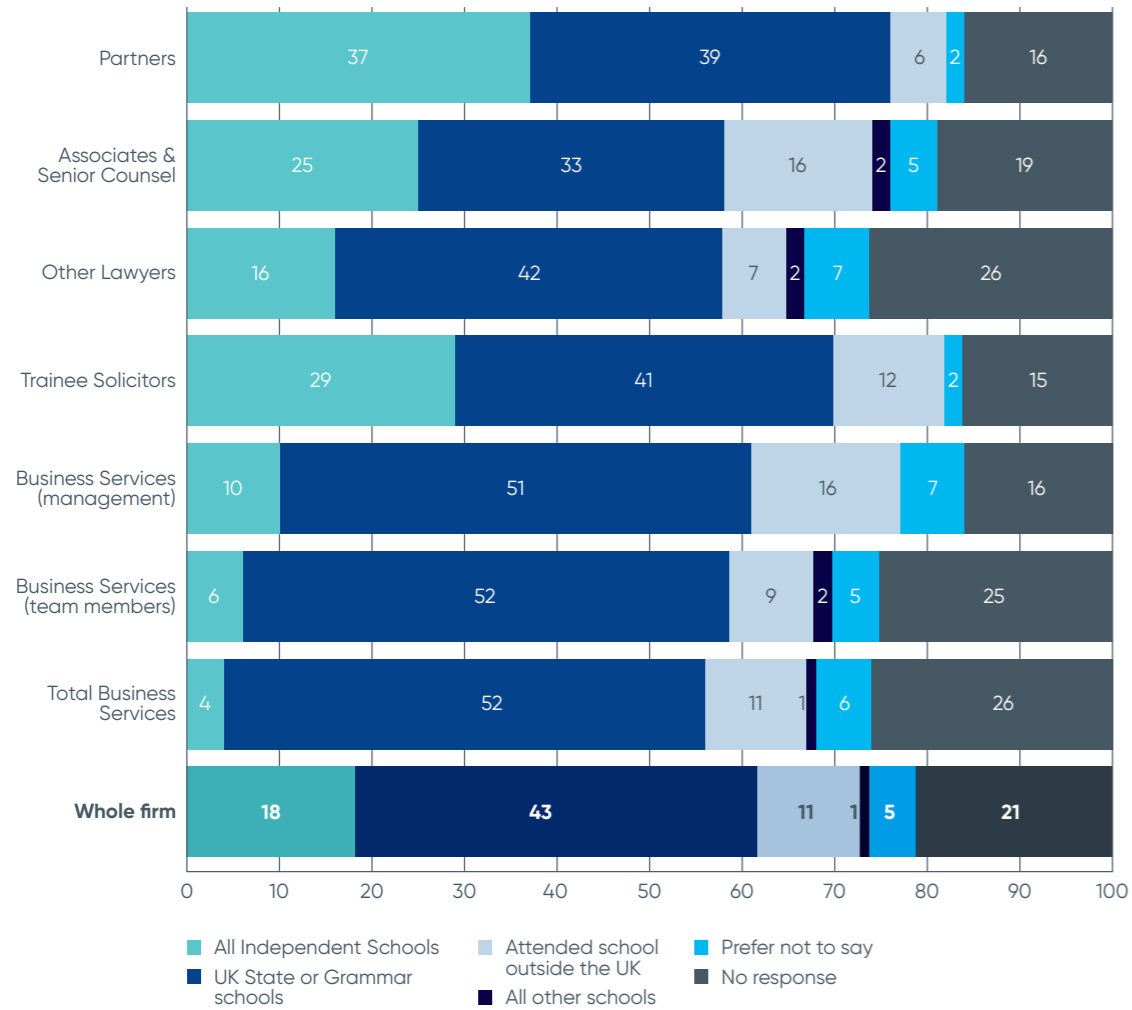

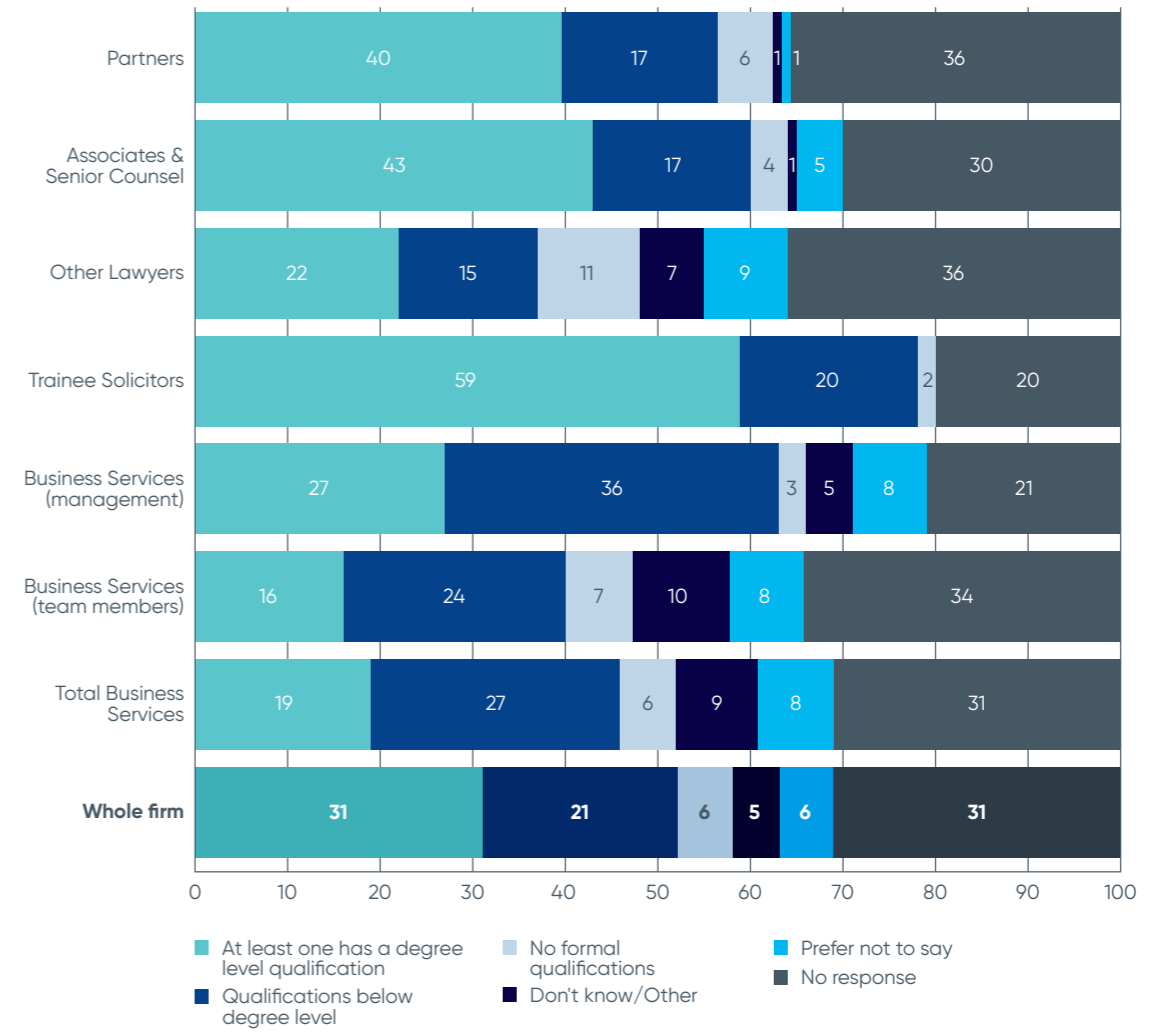

What type of school did you attend between 11-16?

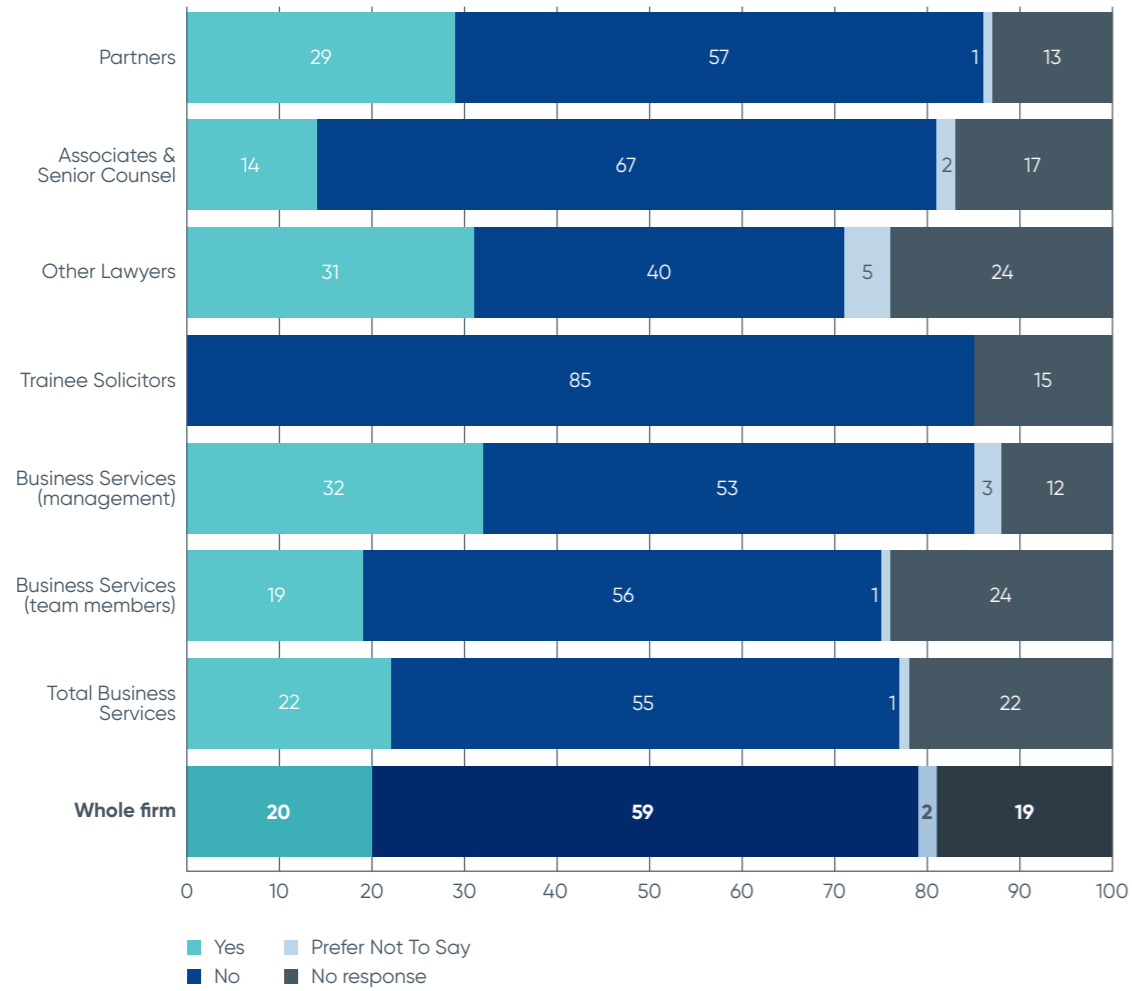


What was the highest qualification achieved by your parent(s) or guardian(s) by the time you were 18?

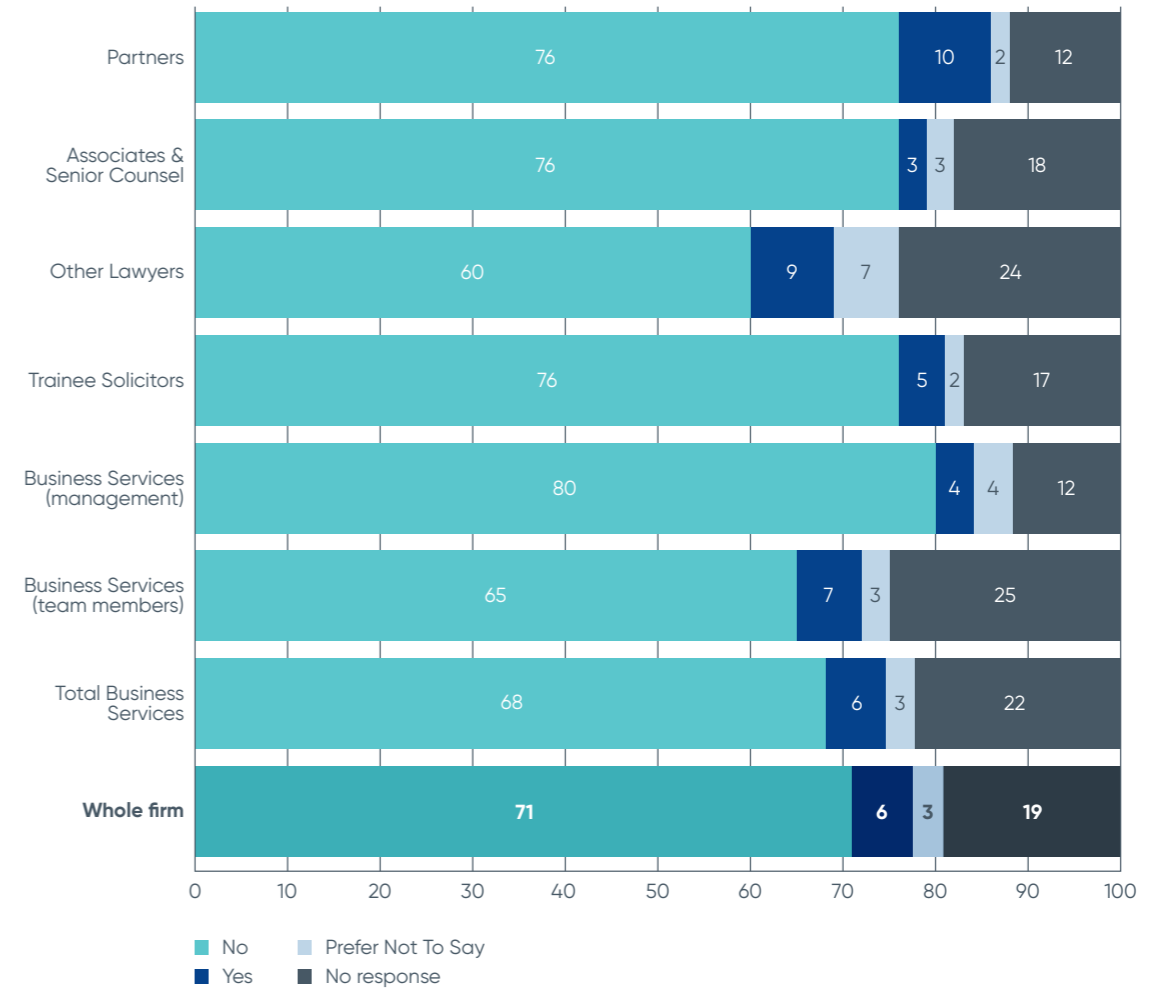


Caring responsibilities

Are you a primary carer for a child or children under 18?

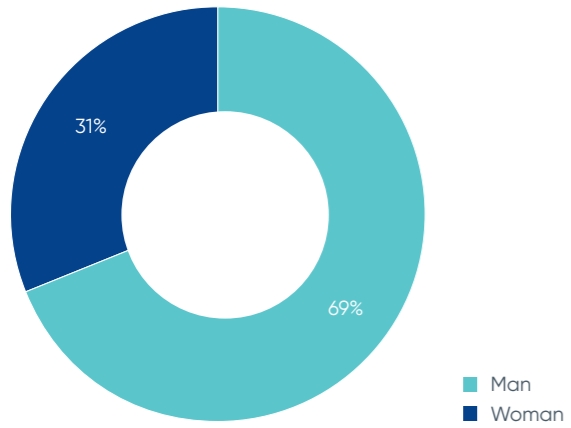


Do you care for someone with physical or mental ill health caused by disability or age?

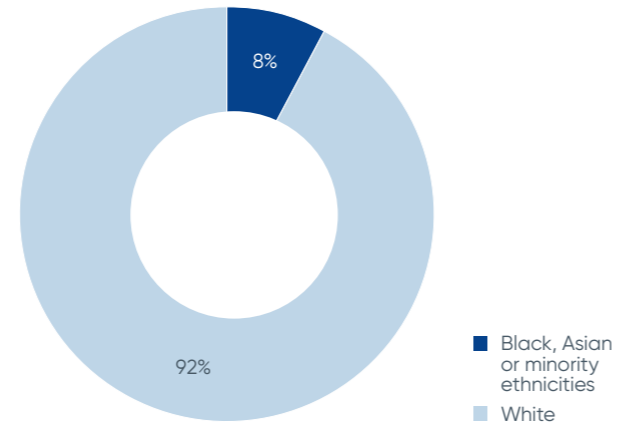

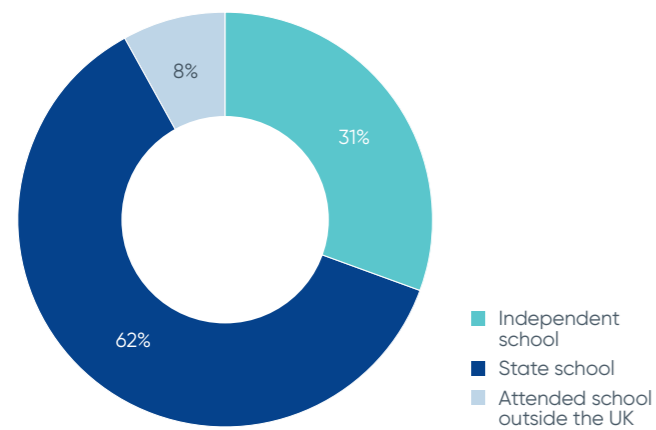

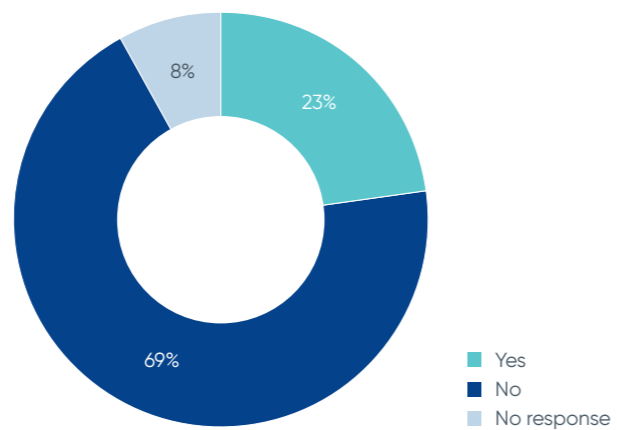
